WHEREAS, the municipal engineer, recommends award the contract to J. Tufaro & Sons Electrical Contractors, Inc. in the amount bid.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Fredon, County of Sussex, and State of New Jersey as follows:

- 1. The bid submitted by J. Tarfuro & Sons Electrical Contractors, Inc. for Emergency Power Generator for Fredon Civic Center.
- 2. The bidder must sign the contract within 14 days of the date of this Resolution and post performance and payment bonds as required by the Bid Specifications otherwise the contract award is void and of no effect.
