Recycling Dates Monday MARCH 11th & 25th

Recycling is every other Monday. Please put your recycling out in a secure unmarked (without a company name on it) container the night before since pickup begins at 5am. SENIOR FREEZE PROPERTY TAX REIMBURSEMENT 2023

Senior Freeze reimburses qualifying seniors and disabled residents for increases in property taxes or mobile home park site fees on their principal residences.

The deadline to file 2023 applications is October 31, 2024.

To be eligible for the 2023 Senior Freeze, you must:

- Be age 65 or older on December 31, 2022, or receive Social Security disability payments on December 31, 2022, and also on December 31, 2023; and
- Own and live in their home or leased a site in a mobile home park for a manufactured or mobile home that they owned since December 31, 2019, or earlier; and
- Paid all 2022 property taxes by June 1, 2023, and all 2023 property taxes by June 1, 2024; and
- Their annual income was \$150,000 or less in 2022 and \$163,050 or less in 2023. With some exceptions, all income must be taken into account, including Social Security, pension, etc.

Qualifying residents may apply online through the online filing portal at njportal.com/taxation/ptr.

2024 Fredon Township Bulk Pick-Up Information

Bulk Pickup is provided for <u>all</u> residential dwellings.
All Bulk pickup will be on the date designated below.

Items must be put out the **NIGHT BEFORE** the pick-up date since pick-up begins at <u>5 AM</u>.

Interior household bulk items such as stoves, refrigerators, furniture, carpets, etc., but <u>not</u> normal <u>household garbage</u> or <u>bagged garbage</u>. Building material, construction debris, other outdoor items and tires will not be picked up!

If it is small enough to fit in a garbage bag or can it is NOT bulk

BULK PICK-UP WILL BE PROVIDED ON THE FOLLOWING DATES in 2024:

Monday April 15th Monday July 22nd Monday October 14



The following items WILL NOT BE PICKED UP for bulk pick-up:

Televisions Laptop Computers Monitors Printers Computers FAX machines

Copiers Tablets

The New Jersey Electronic Waste Management Act bans the disposal of these electronic devices and mandates that they be recycled. These items may be recycled at the following locations: SCMUA Collection Programs - Regular Operations (scale charges apply), Scheduled free annual recycling events, or New Jersey Manufacturers and Retailers.



2024 Recycling Event Schedule



Household Hazardous Waste Days: Saturdays 6/1/24 & 11/2/24
Dispose of oil-based paints, stains, thinners, pool chemicals, mercury, lubricants, chlorine, driveway sealer, fluorescent bulbs, household batteries and more. Limits: 100 lbs. dry waste, 10-gal liquid waste, and 10 fluorescent bulbs per vehicle free of charge. Scale charge for larger quantities.



Electronics Recycling Days: Saturdays 4/13/24 & 10/5/24

Free event! Examples: TV's, desktop computers, laptops, desktop printers and fax machines, cell phones, VCR's, DVD's & CD's, copiers, radio & stereos, etc. (Residents may also drop off some electronics for free during normal business hours. See website for info.)

Dog Licenses were due

January 31st!



Annual dog licenses renewals were due by January 31, 2024. Licenses received after January 31st are subject to a \$5.00 per month, per dog, late fee.

The rabies vaccine expiration date must be after

November 1, 2024.

If your dog's vaccination expires before November 1, 2024, you must have your dog re-vaccinated. The owner is required to supply proof of vaccination from the veterinarian. Click for a list other rabies clinics in Sussex County and Warren County.
