RESOLUTION OF THE TOWNSHIP OF FREDON, IN THE COUNTY OF SUSSEX AND STATE OF NEW JERSEY AUTHORIZING IN REM FORECLOSURE OF TAX SALE CERTIFICATES HELD BY THE TOWNSHIP

WHEREAS, N.J.S.A. 54:5-104.29 et seq. authorizes the Township Committee of the Township of Fredon ("Township") to foreclose tax sale certificates held by the Township for more than six (6) months from the date of the tax sale by summary proceedings In Rem in accordance with the In Rem Foreclosure Act (1948); and

WHEREAS, the Municipal Tax Collector has prepared and presented to the Township Committee a Tax Sale Foreclosure List describing the lands against which such proceeding shall be instituted, a copy of which is attached hereto and made a part hereof; and

WHEREAS, the Township desires to foreclose on these tax liens, by way of In Rem tax foreclosure proceeding in accordance with New Jersey Tax Sale Foreclosure law; and

WHEREAS, this proceeding requires the filing of a complaint in the Superior Court of New Jersey, and authorization must be given to the Township Attorney to institute said action.

NOW, THEREFORE, BE IT RESOLVED that the Township Committee of the Township of Fredon, in the County of Sussex and State of New Jersey, hereby authorizes the In Rem foreclosure of tax sale certificates held by the Township as depicted on the attached Tax Sale Foreclosure List which was prepared and certified by the Tax Collector.

BE IT FURTHER RESOLVED, that Robert B. McBriar, Esq., of the Law Firm of Schenck, Price, Smith & King, LLP is hereby authorized to proceed with the In Rem tax foreclosure of the properties appearing on the attached Tax Sale Foreclosure List by filing a Complaint with the Superior Court of New Jersey and by serving a copy of same upon the Attorney General of the State of New Jersey.
