**RESOLUTION RE: AUTHORIZING EMERGENCY TEMPORARY  
APPROPRIATIONS OF 2020 OPERATING BUDGET FOR THE TOWNSHIP OF

**WHEREAS**, an emergent condition has arisen with respect to the timely adoption of the 2020 Municipal Budget and certain contracts, commitments, or payments are to be made prior to the final adoption of the 2020 Municipal Budget and no adequate provision has been made in the 2020 temporary appropriations for the aforesaid purpose, and N.J.S.A. 40A:4-20 provides for the creation of an emergency temporary appropriations for the purpose above mentioned; and


**WHEREAS**, the total emergency temporary Resolutions adopted in the year 2020 pursuant to the provisions of Chapter 96, P.L. 1951 (N.J.S.A. 40A:4-20) including this Resolution total \$1,134,089.

**NOW, THEREFORE, BE IT RESOLVED** that the Township Committee of the Township of Fredon, County of Sussex, State of New Jersey hereby concur with the provisions of N.J.S.A. 40A:4-20):

1. An emergency temporary appropriation be and the same is hereby made for the titles of appropriations in the amounts indicated on the attached listing.
2. That said emergency temporary appropriations has been provided for in the 2020 Municipal Budget under the titles indicated on the attached listing.
