VOLUNTEER FIRE COMPANY PIERCE FIRE ENGINE 27-71**

**BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF FREDON,
COUNTY OF SUSSEX, NEW JERSEY, AS FOLLOWS:**

Section 1. Capital in the amount of \$23,653.74 is hereby appropriated from the Township of Fredon General Capital Fund Reserve for Fire Apparatus for the major repair and reconditioning of Fredon Volunteer Fire Company Pierce fire engine 27-71.

Section 2. This ordinance shall take effect immediately after final adoption.
