## **TOWNSHIP OF FREDON RESOLUTION 2021-42**

## RESOLUTION REDUCING GENERAL FUND TAX LEVY OF THE FREDON TOWNSHIP BOARD OF EDUCATION 2021-2022 BUDGET

**WHEREAS**, on April 20, 2021, the voters of Fredon Township voted down the general fund tax levy proposed by the Fredon Township Board of Education in the amount of \$4,268,352; and

**WHEREAS**, on May 10, 2021, the Fredon Township Committee and Fredon Township Board of Education conducted a special joint meeting to review and discuss the 2021-2022 budget pursuant to, and in accordance with N.J.S.A. 18A:22-37, N.J.A.C. 6A:23A-9.7, and other laws applicable to the statutory municipal review process; and

**WHEREAS**, the Fredon Township Committee believes that certain line items within the budget need to be adjusted; and

**WHEREAS**, it is the position of the Fredon Township Committee to reflect the wishes of the electorate by reducing educational costs in the school district without adversely affecting the Board of Education's ability to provide a thorough and efficient education; and

**WHEREAS**, following their joint meeting, and in furtherance of the foregoing, the Fredon Township Committee and Fredon Township Board of Education approved a reduction to the general fund tax levy of the Board of Education in the amount of \$300,000.

**NOW, THEREFORE, BE IT RESOLVED** that the Fredon Township Committee hereby certifies a reduced budget amount for the 2021-2022 school year for the Fredon Township Board of Education as follows:

- 1. The original general fund tax levy for the base budget on the ballot defeated by the voters of Fredon Township was \$4,268,352.
- 2. The amount of reduction to the general fund tax levy for the base budget shall be \$300,000.
- 3. The amount of the general fund tax levy being certified by Fredon Township for the base budget is \$3,968,352.
- 4. The specific line-item reductions and/or increases in budgeted revenues for each change are as follows:
